NOTICE TO BOAT OWNERS

1. Boats stored on site must launch on designated day the following spring if requiring crane. All boats must be launched by May 31, 2025. Those remaining after May 31 will be subject to a daily storage fee equivalent to the daily mooring fee and/or may be removed at owner's expense.

2. Cradles/trailers/stands to be removed by June 1, and all debris shall be removed from the site including shrink wrap. Off-site storage for cradles along with necessary transportation can be arranged for a fee of \$120. Cradles/trailers/stands otherwise remaining after June 6 will be subject to a daily storage fee equivalent to the daily mooring fee and/or may be towed away at owner's expense. There is no storage available on the wharf from June 1 to mid October inclusive.

4. All halyards and tarps but be tied securely to prevent nuisance noise on the wharf. Owners are encouraged to make periodic inspections to insure nothing is loose. Additional charges may apply if nuisance noise has to be remedied by others.

5. Any work on boats including bottom cleaning, painting and routine mechanical work and winterization shall be done in a way to prevent contamination of the wharf (for example tarps on the ground, vacuum sanding). Only Environment Canada approved chemicals and bottom paint shall be used.

6. No contractors are permitted to do work on boats unless the owner has verified that the contractor is properly insured with WCB and has instructed the contractor to register with the Civic Marina prior to starting work.

By signing below you agree to be bound by all the terms of this agreement and further that you agree that the Mahone Bay Wooden Boat Society/Mahone Bay Civic Marina and / or Town of Mahone Bay, its principals, officers, directors, employees or agents are in no way liable for actions arising, or to arise, by reason of the hauling, launching, storing or removal of any boats, cradles, trailers or stands.
